**A BYLAW OF THE RURAL MUNICIPALITY OF DUFFERIN NO. 190
AUTHORIZING COUNCIL TO ENTER INTO AN AGREEMENT FOR THE
ESTABLISHMENT OF A MUTUAL AID AREA**

WHEREAS; provision is made in sec. 42 of *The Municipalities Act*, 2006, enabling Council to enter into agreements with other municipalities for the furnishing of fire-fighting services and fire-fighting equipment beyond urban boundaries, on any terms that may be agreed on; and

WHEREAS; the Council of the Rural Municipality of Dufferin No. 190 deems it expedient to enter into an agreement for the purpose of establishing a Municipal Mutual Aid Area, to pool resources if participating municipalities and improve their emergency response capabilities;

NOW THEREFORE; the Council of the Rural Municipality of Dufferin No. 190 in the Province of Saskatchewan enacts as follows:
